

## **IBA – ACQUISITION OF OWN SHARES**

Immediate Release – May 18th, 2021

**Louvain-la-Neuve, Belgium, May 18<sup>th</sup>, 2021** - In accordance with article 8:4 of the Royal Decree of 29 April 2019 executing the Belgian Code on Companies and Associations, Ion Beam Applications SA ("IBA") hereby discloses information in relation to its share buyback program announced on January 12<sup>th</sup>, 2021.

Under this program, IBA has requested a financial intermediary to repurchase up to 357.000 IBA ordinary shares on its behalf under the terms of a discretionary mandate agreement with validity until May 31<sup>st</sup>, 2021, effective as from January 13<sup>th</sup>, 2021, to cover the company's obligations under a long term incentive plan for certain members of its personnel.

In the framework of this share buyback program, IBA repurchased 17.290 IBA shares on Euronext Brussels in the period from May 7<sup>th</sup>, 2021 up to and including May 13<sup>th</sup>, 2021, as follows:

The total number of shares purchased under this program therefore amounts to 334.616. As a result, IBA SA currently holds 808.837 treasury shares (directly and indirectly through its subsidiary IBA Investments SCRL), representing 2,68% of its share capital.
